We are looking for a Learning Support Assistant to join our team at Merchant Taylors' School. You will be someone who is motivated by helping others, patient and resilient. The post is term time only, 37 hours per week and offered on a fixed term contract for 1 year.

You will be required to teach 1:1 and small groups of up to 10 pupils, and support the Head of Learning Support, Teachers and Senior Leadership Team. You will be responsible for providing essential support to our pupils with learning difficulties, behavioural, social and physical disabilities. You will build positive relationships with pupils to promote interaction and a constructive learning environment to support their learning needs. The position requires work to be carried outside of the classroom environment and you will have the opportunity to assist in the planning and delivery of lessons in a very creative and positive setting.
